Upcoming Events – 2025 March Coronet **Heidi's (Asny) report on 2025 Budgets:**

March Coronet's Asny has 3 choices to discuss and vote on; Each are one day event on March 29th, 2025 with an option to have people individually pay for a night or two at Red Lion in

McMinnville for \$140 Q, more if 2 Q's. With a complimentary conference room on Sunday for a Moot meeting in the morning.

- 1. \$500 -McMinnville- First Baptist Church, Kitchen Use (Find Folks to make meals or Soup/Salad Potluck). Warm and inviting community. Several Rooms for classes, meetings, and indoor on carpet if raining or outdoor parking lot space for tournaments.
- \$500- McMinnville- Sue Buel Elementary School, No Kitchen (Yes on Food Truck or Potluck); Large outdoor covered or uncovered Asphalt areas for tournament. As well as a cafeteria with seating or gym, to add own tables and chairs.
- \$1500- Dayton Stoller Family Estate (Winery), Coolers are acceptable with non alcoholic beverages and food; Cater service requested to include at least 50 pp: optional \$20 to cover a box lunch and appetizers before and after court with an open wine/beer bar for individual purchase.

My first choice would be Stoller, they are a good winery to get to know, as per my past work experience with them. Also, the family owns the Evergreen Aviation/Space Museum area; which includes the large oak grove and fields for potential Acorn War event in the future.

I've asked several people who have been event coordinators for Investitures, and they seem to say it is okay to break even or even dip below a little. I, however, don't expect either to happen. I have two projections for Stoller, one with less than 120 pp and one for over 150 pp. I estimate we could make \$600 or more profit with 120 pp. Also, if our pre-registration brings in over 75 pp, I will purchase 1-2 Handicap Biffy's as well.

If the shire would prefer to make more income, then my second and third choices would be FBC and then Sue Buel. Please add your first choice in the chat and I will tally them up and see what folks mostly want to do. Then we will vote on that choice as a shire and I will move forward with that budget and make a bid to Summits.

We decided, First Baptist Church is first choice, School second choice, & Stoller Winery third choice.
